- Easy web-based access



The user will enter their userID and password on the same screen. The user will no longer have to answer challenge questions, although the one-time password will still be required.



General User Guide Update

The latest FBI N-DEx System General User's Guide March 27, 2023 Version 7.0 has been released. This resource can be located on the N-DEx System or www.fbi.gov/ndex.



"N-DEx is a great tool when all of the standard practices have been exhausted. It really captures the ability to get to that non-standard information on the periphery, and deep dive into the extra case information once the big ideas didn't yield any results. I would classify it as a treasure trove of random, but extremely helpful information to give new leads to my cases using state, local, and federal data that isn't culminated anywhere else in one place. After utilizing all the standard systems and protocols, it gives me hope that we're not quite through yet. I have solved many cases now with N-DEx information that I wasn't able to locate anywhere else, even after I had found it in N-DEx. It's just another tool in the toolbelt, but it's highly underutilized, and a breadth of information. I always consider that the worst that can happen is I don't find anything, but after you've done the normal system searches, what are you going to do now if you don't try?"

2022 Excellence in Information Sharing Award The N-DEx System assists in finding individuals in Bloods Gang case

In 2021, an FBI Baltimore Field Office (FO) intelligence analyst worked a large-scale Bloods Gang case which had ties to the entire east coast. Through investigation, the Baltimore FO identified a threat to life for an individual with no known identifiers, other than an alias street name. A confidential source provided vague information about someone posting a police report on social media connected with the threat to life. The analyst observed information in the social media post to identify several possible subjects. The analyst narrowed down the subjects and searched the names through the FBI's National Data Exchange (N-DEx) System. The N-DEx System returned records shared by the South Carolina Department of Corrections, which revealed the street name of one of the individuals identified in the social media post. The analyst located and provided the true identifiers of the person who had a "hit" out on him to the case agent who ultimately notified the correctional institute and FBI Atlanta. The analyst stated, "Without the N-DEx System, the identification would have been further delayed, potentially jeopardizing a life. Without the information provided by the N-DEx record, more investigation into the identified individuals to determine their aliases could have delayed the notification of the threat to life."

SWATTING VCC

National Common Operational Picture (NCOP): SWATTING VCC

NCOP is a VCC for SWATTING events nationwide. The FBI's Office of Partner Engagement (OPE) created and manages this VCC to meet partner requests for a centralized sharing point. It became operational on May 1, 2023, and is used to create a real-time common operational picture of SWATTING events from beginning of incident to closeout for awareness, trends identification, and collaboration.

The NCOP VCC is open to all law enforcement agencies and fusion center partners who have access to LEEP and wish to participate in tracking and sharing information regarding SWATTING calls and incidents in respective jurisdictions.

VCCs are supported by a team of liaison specialists who provide virtual (and/or in-person) training and operational support to requesting agencies. A 24/7 Help Desk also provides continuous assistance to LEEP/VCC users as needed.

Accessing the SWATTING VCC:


If you do not have LEEP access, please go to www.cjis.gov and click the Apply for Account button to apply for a LeepID Account.

Once you have your LeepID Account, you will need to request access to the SWATTING VCC:

- Log into LEEP.
- Select the VCC service from the LEEP home page.
- On the VCC home page, on the left-hand side under "VCC Access" banner, select "Find VCCs".
- In the Search bar, type "SWATTING" which will return the "OPE National Common Operational" Picture.
- Under the title, click on "Request VCC Access".

The VCC is available to <u>any</u> law enforcement/criminal justice users who have access to LEEP to include:

- Federal
- State
- Tribal
- Local
- Territorial

It can be used to manage <u>any</u> events happening in your area such as:

- Law Enforcement Operations
- Special Events (e.g. 4th of July celebrations, marathons, etc.)
- Critical Incident Response (e.g. Active Shooters, Kidnappings, etc.)
- Natural or Man-made Disasters

Launching the New & Enhanced Cyber Shield Alliance on JusticeConnect

You are invited to join Cyber Shield Alliance (CSA) now on JusticeConnect.

This community is geared toward law enforcement (LE) officers and investigators seeking information on cyber-related incidents and toward cyber-security professionals protecting LE network infrastructure.

CSA is an FBI cybersecurity partnership developed for LE to receive and share cyber-related information, promoting KNOWLEDGE, COOPERATION, and VIGILANCE among LE partners. The primary purpose of CSA is to enable agencies to proactively defend and counter cyber threats against their networks and critical technologies while providing LE investigators and officials with the critical cyber information they require.

In building CSA on JusticeConnect, we were able to maintain all the capabilities and resources that were available on LEEP while making significant improvements in the process. CSA on JusticeConnect now has enhanced features and upgrades, including resources not previously available and significantly more in-depth information and documents up to the Unclassified/Law Enforcement Sensitive and Traffic Light Protocol Amber levels.

The increased functionality provided by shifting to JusticeConnect improves the user experience by simplifying their ability to find the information they need and facilitating a more active membership in the Community. All this is now available and can be accessed via the same CSA icon on the LEEP home page!

Accessing CSA on JusticeConnect:

- 1. Establish a LEEP account. (If you do not have a LEEP account, you can apply for one by navigating to <u>cjis.gov</u> and selecting "Apply for an Account.")
- 2. After logging on to your LEEP account, navigate to your profile, click "Yes" next to "Participate in JusticeConnect," then click "Submit."
- 3. Once you have access to JusticeConnect, go to the LEEP home page and find the CSA icon and click to open.
- 4. Once on the CSA home page, click "Join this Community" to obtain full access.
- 5. Once your CSA access is approved, you will have access to all community applications on CSA, including all documents, information, and training opportunities available to the CSA community.
